Infomart Corporation Appoints Third President and CEO Osamu Nagao

Infomart Corporation resolved at its Board of Directors meeting today that Advisor Osamu Nagao, formerly of Mitsui & Co., Ltd., will take over from President and CEO Shoji Metabi effective March 23, 2018. Also effective March 23, 2018, Executive Managing Director Naotake Fujita will assume the position of Vice President and Representative Director, and Director Osamu Nagahama the position of Senior Managing Director.

The above appointments will be formally confirmed on approval of the 20th Annual General Meeting of Shareholders and the Board of Directors meeting to be held on March 23, 2018. Shoji Metabi will be appointed Chairman and Director on the same day.

Under the leadership of President Shoji Metabi, the Company has grown its B2B platform business by pursuing medium-term management strategies of aggressively increasing market share in the food service industry (expanding use of B2B Platform Ordering and B2B Platform Food Standards Database) and making its electronic invoicing platform a de facto standard (spread of B2B Platform Invoicing to all sectors). With the goal of further growth of B2B platforms, the Company decided to appoint from outside its ranks Osamu Nagao as its new President and CEO because of Nagao's expertise in organizational management and improving the value of growth companies, and his wealth of experience in overseas businesses, investment, and M&A.

From within its ranks, the Company has appointed Executive Managing Director Naotake Fujita as Vice President and Representative Director. Fujita has many years' experience overseeing the Company's administrative division and IR activities. This means the Company will be led by two Representative Directors. Director Osamu Nagahama will be appointed Senior Managing Director tasked with strengthening the Company's development structure. The Company decided to make these management team appointments for highly specialized management and nimble operational decision-making to ensure further business growth.

Osamu Nagao has experience of domestic and overseas investment in IT, food service, and drug discovery sectors as head of venture capital business at Mitsui & Co. He has excelled in diverse business areas in this major organization, such as formulating and implementing business strategies, serving as CEO of an investment company, and being assigned to growth businesses to improve their management. He also has extensive experience in doing business globally, mainly in the Americas, China, and Asia, which helped him build a relationship based on mutual trust with the Company. The Company believes Nagao has the outstanding knowledge, experience, and executive ability that make him the best candidate to steer Infomart Corporation into the next stage of growth.
